1. WHAT ARE COOKIES?

Cookies are small files stored on the hard drive of users' and visitors' devices and used to access the Website. A cookie file allows us or third parties to recognize you as a user(visitor) and make it easier for you to use the Website later.

These cookies allow us to track the use of the Website and its functionalities. Using them enables us better and more effectively provide Services to users and visitors and personalize the Website.

2. HOW DO WE USE COOKIES?

When you visit the Website, various cookies may be stored on your device. We may use cookies to recognize repeated visits, the type of content viewed and other sites to which you were redirected from the Website, the time when each page and section of the Website was opened, and the functions used.

All Personal Data contained in cookies are processed based on the consent of the relevant subject following the J'JO Privacy Policy.

We use both persistent and session cookies, as well as their varieties, for the operation of the Website:

- Essential cookies** Necessary for the normal functioning of the Website. We may use these cookies to authenticate users, prevent fraudulent use of accounts, or provide certain features of the Website.
- Analytical and performance cookies** They allow us to recognize users and track their activity on the Website, helping to improve the Website's performance.
- Functional cookies** They are used for recognizing repeated Website visits. They allow us to personalize the Website content, address users by name, and save selected settings (for example, language or region).
- Targeting cookies** Track the process of using the Website, open pages, and links used. Using this information, we make the Website and materials more useful for our users and adapt them to specific preferences. We may also transfer this information to third parties for the same purpose.

3. SETTING UP THE USE OF COOKIES

To find out how to delete cookies and how to configure deletion or refuse them, use the help function in your web browser.

Please note that if you delete cookies or refuse to use them, you may lose access to some of the Website's features. For example, you may be rejected for logging in to your account and saving settings, and some pages will not display correctly.
